Both the Presidential Limousines ("PL") Service Contract and this Addendum must be signed and returned with a deposit to confirm the reservation. The Passenger Form on the next page must be filled out completely and handed to the Chauffeur prior to service.

PL will discuss with the client whether or not a chaperone is needed depending on the number of passengers, their ages and the itinerary. The PL Chauffeur is not permitted to leave the vehicle unattended to supervise and/or look for passengers.

Customer and responsible party must provide a copy of the Presidential Limousines Service Contract and Addendum to all minors occupying the PL vehicle and their parents/guardians.

Minor Passenger Agreement for Limousine Service

- ➤ It is unlawful for a minor to possess or consume alcoholic beverages or illegal substances before, during or after the delivery of the Services.
- ➤ Chauffeur retains the right to refuse carry-on, placement or use of any bags or parcels in the PL vehicle if it is reasonably determined, within PL's sole discretion, that they may contain alcoholic beverages or illegal substances.
- ➤ If it is determined at any time that any underage minor passenger(s) is/are found to have in their possession, or have been consuming, alcohol or an illegal substance(s) during the course of the Service, the Service shall be terminated immediately. PL reserves the right to notify parents and/or guardians to come pick-up the minors and their Guests, and/or notify local law enforcement personnel.
- ➤ If termination results, all money shall be forfeited and parents or guardians shall be notified. Chauffeur shall retain the option of returning to point of pick-up or ending the service at the point of the infraction. Any Chauffeur overtime necessitated by early termination will be charged to the credit card on file.
- There will be no smoking in the vehicle at any time or within ten feet of the vehicle. A minimum fee of \$250.00 will be assessed for any violation of this provision. PL retains the right to charge Customer's credit card on file with PL.
- At no time during the course of the Service will individuals not listed on the Passenger Form be permitted access to/or transportation in the vehicle or its compartments.
- > The divider window/door between the Chauffeur and the passengers will remain open at all times.
- ➤ Each parent or guardian of a minor passenger must provide a working contact phone number in case of a violation or emergency. PL assumes no liability for the failure of any Customer or Guest to accompany the vehicle to the drop off location other than a reasonable attempt to notify a parent or guardian of such failure.
- ➤ No passenger shall open or otherwise attempt to use an Emergency Window/Exit EXCEPT in the event of a real emergency. Each violation of this provision shall result in a minimum \$100.00 fee per window/exit opened. PL retains the right to charge Customer's credit card on file with PL for all fees assessed.
- The Customer assumes full financial liability for any damage to the vehicle caused during the duration of the rental and/or delivery of Services. A minimum fee of \$250.00 will be assessed for any interior cleaning and/or repair required as a result of inappropriate behavior or negligence.
